



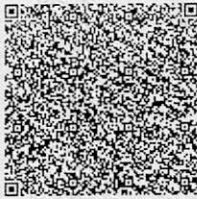

DEED OF TRUST

This **DEED OF TRUST** is made on today, the 29th day of July, 2024

BY AND BETWEEN

Dr Rajendra Nath Gogoi, son of Late Sarat Chandra Gogoi, aged 60 years resident of Banipur, By Lane 3 Dibrugarh-786001, District Dibrugarh, Assam, hereinafter called the **AUTHOR OR SETTLER OF THE TRUST** (which term unless repugnant to the context shall include his heirs, executors, administrators, and assigns etc.) of the **ONE PART**

AND

1. **Dr. Abhijit Kumar Handique** son of Sri Kumud Chandra Handique, aged 55 years resident of Arubhi, Banipur Dhakeri Gaon, , Dibrugarh-786003, District Dibrugarh, Assam,
2. **Dr Rajendra Nath Gogoi** son of Sri Sarat Chandra Gogoi, .aged 60 years resident of Banipur Bylane 3 Dibrugarh-786001 District Dibrugarh Assam,
3. **Dr Arundhati Handique** wife of Dr Abhijit Kumar Handique aged 48 years resident of Arubhi, Banipur Dhakeri Gaon Dibrugarh- 786003 Assam.
4. **Mrs Gayatri Gogoi** wife of Dr Rajendra Nath Gogoi, aged 51 years resident of Banipur, Bylane 3 Dibrugarh-786001 District Dibrugarh, Assam,

All hereinafter jointly referred as **BOARD OF TRUSTEES** (which term unless repugnant to the context shall include their heirs, executors, administrators, and assigns etc.) **OTHER PART.**

WHEREAS, the **Author or Settler of the Trust** is having a desire to create a Trust by the name of **MAEYES FOUNDATION** at Graham Bazar, Tinkunia, Dibrugarh 786001, Assam to provide medical assistance and other assistance to the poor and needy people of the Society with the help of other organizations and non-profit charitable

organizations whose mission is to provide Medical assistance and medical mission for Eye treatment for poor and needy persons of the Society with the support and participation of others towards Corpus of the Trust.

AND WHEREAS, the Author or Settler of the Trust absolutely, irrevocably and forever dedicated and donated Rs 11000/- (Rupees Eleven Thousand only) by Cheque to the Trustees as Initial Contribution for the objects of the Trust and also authorizing the Trustees to collect funds for the Trust and also for spending on its charitable, religious objects and other objects of the Trust.

AND WHEREAS, it is further declared that the main objects of the Trust is to give medical assistance and other assistance for eye treatment to poor and needy people of the Society and also for other charitable purposes of the Trust.

NOT WITHSTANDING, anything contained hereinabove, the income of the Trust by donation, payment by Author or Settler to the Trust and other income will be solely be spent for the objects of the Trust and in no way distributed to the Trustees and all other interested persons as prohibited under the Income-tax Act, 1961.

AND WHEREAS, the accounts of the Trust will be audited by a firm of Chartered Accountants and the first Auditors will be appointed by the Trustees and they will be eligible for re-election.

AND WHEREAS, it is also felt by the Author or Settler of the Trust, all Trustees and the interested persons that the money contributed or to be contributed by them will not be sufficient to meet the charitable objects of the Trust which will be met with the assistance of charity and donation,

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The Trustees hereby declare that they and survivors or survivor of them or other Trustees thereof for the time being will hold the said sum of Rs 11000 (RUPEES ELEVEN THOUSAND ONLY) made over by Author or

Settler of the Trust to the Trustees as aforesaid and all gifts, contributions, subscriptions, donations, bequests and other moneys or property as and when the same shall be paid to or vested in them and the moneys, investments and property from time to time representing the same upon the Trust to apply the same for the purposes of medical assistance, activity of Charity in the territories of India. **PROVIDED HOWEVER**, no part of fund or income thereof be applied to any purpose outside India except in accordance with the approval of the Central Board of Direct Taxes, Government of India.

2. The Trust shall be known as **MAEYES FOUNDATION** with its Head Office at Graham Bazar, Tinkunia, Dibrugarh – 786001 Assam with power to the Trustees to change the name of the Trust, if the Trustees so decide.
3. The main objectives of the Trust is to
 - 3.1 provide affordable treatments to provide affordable and accessible eye care services to the underserved population.
 - 3.2 do screening programs to conduct eye screening camps in rural and urban areas.
 - 3.3 do research and development to support research and development in the field of ophthalmology.
 - 3.4 do awareness program to raise awareness about eye health and preventive care.
 - 3.5 do Education and training to train healthcare professionals and support ophthalmology education.
 - 3.6 do infrastructure development to establish and maintain eye hospitals or clinics and to equip facilities with necessary medical instruments and technology.
4. The number of Trustees shall be Four. The Trustees shall be Trustees for their life time but any Trustee may resign by giving notice in writing to his / her Co-Trustees and shall also cease to be a Trustee, if requested in writing by 3/4th of the remaining Trustees or the number nearest thereto. Appointment of Trustees either to fill up a vacancy or as additional Trustees shall be by resolution passed of the Trustees.

5. The general management and control of the Trust for the purpose of managing the Trust Affairs and properties and carrying out the objects of the Trust aforesaid shall be vested in the Board of Trustees and without prejudicing to the generality of the objects and powers above mentioned they shall have powers to do all or any of the following things, that is to say-
- a) That the entire Trust Property shall vest in the Board of Trustees.
 - b) That the Board of Trustees shall be in management of the affairs of the Trust and shall be run by Chairman, Secretary, Treasurer, Medical Director. The Board may appoint Officers and/or Agents and who shall exercise such powers and performs such duties as determined by the Board.
 - c) That the Board of trustees shall make necessary efforts to raise fund for the trust.
 - d) That the Board of Trustees shall be empowered to receive donation, grant, contribution, fund, subscription and aid and also to disburse necessary fund, grant to any application on the terms and conditions as may be decided by them from time to time. The Board of Trustees can receive donations towards the corpus or current Fund of the Trust.
 - e) That the Board of Trustee are empowered to purchase or sale movable or Immovable properties for benefit of the Trust.
 - f) That the Board of Trustee are empowered to construct hospital, day care, educational Institution, Doctor Para-medical and Nursing Hostel for Eye Care for the benefit of the Trust.
 - g) That the Board of Trustees is empowered to appoint or dismiss employees and also to determine the terms and conditions of service of the employees.

- h) That the Board of Trustees is empowered to file suits on behalf of the Trust and also compound or settle any legal proceedings taken against or taken on behalf of the Trust in any time.
 - i) That the Board of Trustees is empowered to appoint legal advisers, Chartered Accountants or other Advisers as may be found convenient from time to time.
 - j) That the Board of Trustees is free to invest all moneys which shall require investment in any manner as they think proper and permissible under the operative national laws. However, they shall not invest/deposit with any private person/firm/company etc.
 - k) That the Board of Trustees is empowered to open Bank Accounts for and on behalf of the Trust and in the name of the Trust. The accounts of the 'Trust' shall jointly be operated by either of chairman or secretary and treasurer. They may sign and endorse cheques and withdraws interest on any security or any other investment made and to issue receipt, release and discharge for the same.
 - l) That the account shall be maintained for the Trust and the Treasurer shall be responsible for maintaining the same and to prepare the annual Accounts and shall arrange for getting them audited by duly qualified Auditor. The Auditor for the Trust shall be appointed by the Trustees. It shall fix his remuneration. The Audited accounts shall be communicated to MAEYES FOUNDATION.
 - m) That the management expenses of Trust shall be reimbursed from Trust Fund.
6. The First accounting period of the Trust will be from 29th July 2024 to 31st March, 2025 and thereafter accounting year of the Trust will be financial year ending 31st March every year.

7. The Trust is established for the benefit of public in general and not for the benefit of any specific Individual.
8. Fund / Properties of the Trust shall be used only for the objectives of the Trust and not for any other purpose.
6. The Trust or Trust funds shall be irrevocable for all times.
7. The Trustees shall be chargeable only for such money, stocks, shares , other assets both immovable and movable and funds as shall actually come into their hands and shall not be answerable or accountable for neglect, default , acts or omission or commission of the other Trustees nor of any Bankers or other persons with whom the Trust Properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.
8. The receipt of a person authorized by the Trustees or a Resolution of the Board of Trustees for any money paid or any property transferred or delivered to the Trustees in the execution of any of the Trusts or powers thereof or for the purchase money of any property authorized to be sold shall effectually discharge any person or persons so paying or transferring or delivering.
9. The Trustees will not be entitled to receive any remuneration as Trustees but may reimburse themselves of all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
10. The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulating the meeting of the Trustees. In the absence of such regulations:

- a. All matters will be decided by the majority and three Trustees shall form a quorum for the meeting of the Trustees.
 - b. Resolution passed without any meeting of the Trustees and evidenced in writing under the hands of 3/4th of the Trustees shall be as valid and effectual as a resolution duly passed at a meeting of the Trustees.
11. It is expressly declared that no part of the Trust property or its income shall be applied for any purposes which will be constructed as being subject to the restriction and limitation herein contained and contained in the Income-tax, 1961 and statutory modification thereof.
 12. In the event of dissolution of the Trust, the entire Trust Funds shall be realized and first be used for payment of liabilities of the Trust. The assets left, if any, shall be distributed to other Trusts or Associations having similar objectives and in no event it shall be distributed in any manner, to any of the Board of Trustees or their relatives or related concerns.
